 - S. F. Austin will invite parents to annual meetings to explain the state mandated assessment program [State of Texas Assessments of Academic Readiness]. Parents will also be encouraged to attend at least one parent teacher meeting each year.
 - The District will hold an annual curriculum meeting to review the adopted curriculum with parents.
- 5. S. F. Austin will provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children.
- S. F. Austin will provide each parent information about their child's district and state assessments.
- 7. S. F. Austin will notify parents in writing on the first day of the fifth week that their child has been assigned or has been taught for four (4) for more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002). All S. F. Austin's teachers are currently highly qualified.
- 8. S. F. Austin will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions below:
 - the state's academic content standards
 - the state's student academic achievement standards
 - the state and local academic assessments including alternate assessments
 - · the requirements of Part A
 - how to monitor their child's progress
 - · how to work with educators
- S. F. Austin will coordinate and integrate parental engagement programs and activities with Head Start, Even Start, public preschool, and other programs.
- 10. S. F. Austin will take the reasonable actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand.
