SHAC Minutes – October 20, 2021

- I. Meeting was convened at 1:30 p.m. by B. Ezell via Zoom. The meeting is being recorded. - II. Parent Volunteer for Co-Chair Melissa Portnoy
- III. Council Purpose & PoliciesB. Ezell reviewed the purpose and policies of SHAC. The SHAC guide was shared with members via email on 10.19.2021.
- IV. Six Snack Exempt Days for Fundraisers
 Barbie Ezell reviewed and explained the campus snack exempt days. Virginia Lopez noted a typo on the MS schedule and questioned whether the date is December 11 or 14. Barbie Ezell confirmed it is December 14. Melissa Portnoy motioned to accept the campus snack exempt days and was seconded by Joyce Johnson. Members voted in favor of approving the exempt days submitted by

 Jackie Milligan from the Coastal Bend Wellness Foundation provided a formal presentation on Project R.U.S.H. (Realistic Understanding of Sexual Health). Jackie.
 Milligan will email the curriculum to be shared with SHAC and district staff for review.
 Audra Gerick asked what grade level the program is for and Jackie. Milligan indicated that it is designed for students age 15 19. Sandra Corpus inquired about the number of modules and how often they would be taught. Jackie Milligan reported that we will work with the district to tailor the courses to what best fits with the campus schedule. Sandra Corpus asked if this could be provided through health classes. Jackie Milligan indicated that, yes, this would be really good fit for schools. Marci Martinez asked if this would be recommended for the MS level. Jackie Milligan indicated that this program is evidence based for students aged 15 19.

VI. Self-Responsibility Classes

Barbie Ezell reported that the district utilizes the Women's and Men's Health Services of the Coastal Bend to provide these classes for students in grades 5-8. Audra Gerick indicated that TM Clark and WC Andrews have scheduled their classes for grade 5 with those dates scheduled for three days prior to Thanksgiving break. The parent meeting is scheduled for November 11. Barbie Ezell will reach out to MS, SF Austin, and East Cliff regarding dates for the classes. She also reminded staff about providing the parents an opportunity to review the curriculum and materials and the choice to opt out of the program for their child. Audra Gerick indicated that they require parent permission forms for opting out and those students do not attend the training. Kayla Knowlton added the TM Clark and WC Andrews dates, November 16, 17, & 18, in the chat.

VIII. SHAC Triennial Survey

Martha Rose reviewed the SHAC Triennial Survey which is a requirement every three year. She explained the scoring methodology and how we will use the scores to align to our Wellness Plan and Balanced Scorecard.

IX. Board Policy, Wellness Plan & Balanced Scorecard

Martha Rose indicated that it is a great time to review our policies and update our Wellness Plan which was updated in 2018. We will work in teams to align the Wellness Plan to board policy and the Balanced Scorecard. We will send an email to SHAC members in order for them to join a team of interest and work to create SMART goals for the Wellness Plan.
