- a) Summary of the case (what’s the story? What happened?)
 - b) Which part or parts of the Constitution are in question and why?
 - c) The decision of the court (i.e. “7-2 in favor of Smith”) with a **summary** of **both** the **majority** and **dissenting opinions** (if any).
 - d) Do you agree with the majority or the dissenting opinion? Why?
 - e) Why is this case important in the study of American History? What was its impact?
 - f) Turned in with a cover page and bibliography, written in complete sentences, with one inch margins, double spaced, using 12 point Times New Roman font, using proper grammar, spelling and punctuation.

3. Part B(100 pts) Prepare a Powerpoint, Poster, or other product to be presented

To the class which includes:

- a) 6 visuals/drawing/graphics which explain and tie in to the cases
- b) For both cases: an outline of the important events which led it to the Supreme Court
- c) For both cases: Who won the case and why? Include the Court's vote and an important quote from the case.
- d) For both cases: A description about how the United States was transformed due to the Supreme Court's decision.

**Essays are due on the first Friday of school after the summer break.

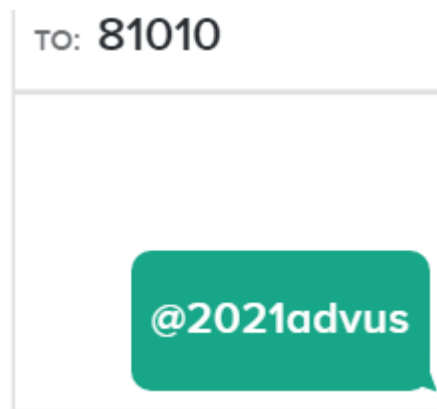
**Posters/Powerpoints are due on the day you present to the class.
